Introduction

This manual is designed to assist you in navigating the new look Taxsaver on-line ordering system.

Background

The Taxsaver scheme commenced in 2000 due to changes in legislation in that years budget. There are now over two thousand companies ordering tens of thousands of tickets for employees.

Irish Rail introduced an on-line ordering system in 2005 which has been operating successfully for the past six years. Bus Éireann and Dublin Bus are now moving onto the Taxsaver on-line ordering site that will enable company administrators to purchase all Bus Éireann, Dublin Bus and Irish Rail tickets on-line.

How do these changes affect your company?

- For those of you who have used the current Irish Rail on-line system, the screen layout will be different but the overall functionality of the system remains the same.
- > For **new users** of the on-line ordering system, you must have the following:
 - Registered email address
 - Allocated password forwarded by the system.

Invoicing and Ticket Distribution

Please note that invoicing and ticket distribution will still be undertaken by each company directly.

- All Bus Éireann on-line orders will be invoiced, issued and delivered by Bus Éireann.
- All Dublin Bus on-line orders will be invoiced, issued and delivered by Dublin Bus.
- All Irish Rail on-line orders will be invoiced, issued and delivered by Irish Rail.




Screen Shots of the New System
