About TFI Leap Cards

TFI Leap Card is the most efficient way to pay for travel with savings up to 30%. You can use it on Dublin Bus, Luas, DART, Commuter Rail, Go-Ahead Ireland services and on Bus Éireann's Commuter services in the Greater Dublin Area (GDA) plus Athlone, Cork, Galway, Limerick, Sligo and Waterford.

Simply buy your TFI Leap Card, top up with Travel Credit and away you go. You can purchase Bus Éireann 24 hour and 7 day Leap Zonal tickets from the driver, TFI Leap Card Payzone Outlets and TFI Leap Card website to save more.

Employee Information & How to Order

The Tax saver TFI Leap Card Zonal tickets give added benefit with the flexibility to use the ticket on all Leap designated services across the zones or zone specified on the ticket.



Step 1 Order

Contact your company contact person who will place the order on your behalf.

Step 2 Travel

Your employer will purchase the Tax saver Leap ticket from www.taxsaver.ie. Bus Éireann will send the card directly to your workplace. The ticket will entitle you to unlimited travel in the zone or zones specified on the ticket.

Step 3 Top Up

To renew your TFI Leap Card product onto your current card, please do one of the following:

- 1) Go to any Payzone TFI Leap Card agent where you will present your card to the instore validator or ask for a "balance check"
- 2) Use the collection device in Busáras
- 3) Use the NFC enabled Android Phone App: <https://about.leapcard.ie/leap-top-up-app>.
